

ADVERTISEMENT FOR BIDS FOR CONSTRUCTION OF
POND LINER REPLACEMENT

for the

CITY OF WACO, GEORGIA

Sealed proposals will be received by City of Waco, Georgia at the City Hall, P.O. Box 201 or 185 Atlantic Avenue Waco, Georgia 30182 until 11:00 a.m. local time, Tuesday, July 23, 2019 at which time and place they will be publicly opened and read. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of sixty (60) days.

All Bidders must have a State of Georgia Utility Contractor License and must employ a state "Utility Manager" certificate holder who will have oversight of all the work.

The work to be done consists of furnishing all materials, equipment and labor necessary to:

Remove and replace liner in existing wastewater ponds; complete with bypass pumping and other appurtenances. Project also includes replacing an existing groundwater monitoring well.

Time allotted for construction is 90 consecutive calendar days for substantial completion and 120 days for final completion.

Proposals for the complete work in one general contract shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

The project is proposed to be funded with an Appalachian Regional Commission grant. All Appalachian Regional Commission requirements apply.

All proposals shall be accompanied by a Bid Bond drawn in favor of the City of Waco, Georgia, in the amount of at least 10% of the lump sum bid for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for the City of Waco, Georgia. Each bond shall be equal to 100% of the contract amount. The Bid Bond shall be forfeited to the City of Waco, Georgia as liquidated damages if the Bidder fails to execute the contract and provide Performance and Payment Bonds within 10 days after being notified that he has been awarded the contract.

Drawings and Specifications are open to public inspection at the office of the City of Waco, Georgia and at the offices of Turnipseed Engineers in Augusta and Atlanta, Georgia.

Copies of the plans and specifications may be obtained from Turnipseed Engineers, 2255 Cumberland Parkway, Building 400, Atlanta, Georgia 30339, upon receipt of \$100.00. Additional reduced drawings are available for \$75.00.

Digital copies of the documents are not available.

Upon receipt of all documents in undamaged condition within 30 days after the date of opening of bids, half of the deposit will be refunded.

The difference between the deposit and the amount refunded represents the cost of reproduction. No refund will be made for documents received after 30 days or in damaged condition.

The Owner reserves the right to reject any or all bids and to waive informalities.
